- I. Call to Order Larry Stanton called the meeting to order at 7:21 pm.

- II. Introduction of Visitors- No visitors attended the June meeting.
- III. Reading Minutes of Preceding Meeting--

The May 21,2019 minutes were presented. There were several items discussed by the members of the ACC about proposed permits and variances. These notes were amended, the Minutes were sent out via e-mail, with motions to approve the amended minutes. Larry Stanton made a motion to approve the minutes as amended. Charlie Stoddard seconded the motion. The minutes were approved as amended and will be posted on the website.

IV. President's Comments- Larry Stanton- Larry has written a letter to the Core of Engineers to stop the discharge of effluent into the Bayous. Request has also been made to storm - proof the pumping plants.

We have had several long time neighbors pass away recently, and there have been requests that this information be sent out as an email blast. It was suggested that this would be a duty of the At Large Board Position- James Pocza. Information could be sent to a Board Member, who would then pass this information to James, who will send it out to the homeowners.

#### V. Reports of Committees

- A) Vice President Tom Ehardt- Tom will schedule with Leigh Adkins to schedule the Annual Audit. He will send out an e-mail blast to residents with the rules about Trash Pick Up.
- B) Secretary Mary Spiller As soon as the Minutes from the May 21<sup>st</sup> meeting are amended, they will be sent to the Board for approval.
- C) Treasurer- Leigh Adkins- (See separate sheet) Leigh presented Budget to Actual. The Security Vehicle's Insurance switched to Progressive. (\$400) Four homeowners have not paid 2019 Annual Dues. Four letters have been sent. Larry will personally visit each of these homeowners. Garbage is \$900 over budget, but the Spring Flick is \$71 under budget. Chad Roberts got a bid for Security Cameras to be placed at the entrances to Briarbend. It would cost \$6000, plus annual maintenance. The Board voted not to proceed at present, but to present this information at the Fall Semi-Annual Homeowners Meeting.
- D) Security Chad Roberts- The Patrol Car needs a new Transmission It is not driveable at present.. Chad took it to the Texaco Station on Voss Rd. and the estimate was

- \$4000. Chad will obtain other estimates and then proceed with the repairs. No other Security report at present.
- E) Super neighborhood Peter Blomquist No Report
- F) ACC Scott Summerville- The ACC has received a request from the homeowner at 2611 Stoneybrook to add on to the back of the home. This is under review. At 7810 Burgoyne, plans are being reviewed to add on to the back of the house. They are looking at the plans now. If a variance is requested to use Hardee Plank, it will be submitted to lawyers for the variance forms. The new homeowner at 7802 Wickersham has requested a variance to move the garage opening to face Stoney Brook. The City has approved moving the light pole so that the garage could face the street. Scott made a motion to approve the variance, Mary Spiller seconded. The motion passed.
- G) Social and Community Relations- Jessica Strehlow Jessica was absent, and emailed to say she had no report at this time. She will start Halloween Party preparations in August.
- H) Legal- Charlie Stoddard Charlie has received complaints about trash pickup. Trash not being picked up behind gates, bins left on the curb, regular trash being mixed in with recycling. He has spoken with Kevin, the owner of Texas Pride, who was very responsive to correcting any problems we are having . Charlie has also sent Kevin a map of Briarbend to facilitate corrections.
  - Charlie has contacted a homeowner concerning a nuisance with his property. Our attorneys have been contacted and fines will be levied. Some improvement of the property has been addressed.

- VIV. Adjournment- Chad Roberts made a motion to adjourn and Charlie Stoddard seconded. The meeting was adjourned at 8:54pm.
