I. Call to Order- Robbie Guinn called the meeting to order at 7:09pm

II. Introduction of Visitors- There were no visitors and therefore no discussion.

A) **Reading Minutes of Preceding Meeting-** Minutes of the February 21, 2017 Board Meeting were sent electronically prior to the meeting, reviewed by the Board, there were no additions or corrections. Motion to approve made by Charlie Stoddard, seconded by Larry Stanton. The minutes were approved and will be posted on the Briarbend website.

IV. Reports of Committees

A) **Vice President**-Larry Stanton- Kathy Johnson and Peter Blomquist were elected to the Board at the April Semi-Annual Meeting. Only 25 % of residents voted and about the same number attended the Semi Annual Meeting.

1 Speed Cushion - Larry has contacted a contractor, but he has not called back. \$2500 for the Cushion and \$2500 for installation, tax exempt. (Traffic Calming Devices). It is needed on Burgoyne. There is a possibility that through Councilman Greg Travis' Office, we can split the cost. Do we want to do it on our own, or wait for the City to install it and we would have to pay half. It was decided to get more information on a timeline with Greg Travis' Office. (See discussion concerning this in Superneighborhood).

- B) Secretary- Mary Spiller- No Report at this time
- C) Treasurer- Leigh Adkins-

1. **Financials** – Hard copies of Budget passed out. Only 4 homeowners still have not paid for 2016, one has paid partial. For 2017, there are 5 have not paid. See Expense/Category sheet.

2. Audit- Rene Garza and one other neighbor will audit 2016 the books. Jennifer Mire made the motion to proceed with the audit, Casey Koehler seconded. The motion was approved. Rene will move forward.

D) **Security-** Chad Roberts- We have Budgeted \$7040 and we have spent \$ 6776. We may need to reallocate budget for Security. There is going to be increased cost in Security Budget due to the Police car we purchased for maintenance. This is an adjustment process since this is a new cost that has been accrued recently.

Burglary of a motor vehicle report filed today in Briarbend. No response yet. The Stoneybrook Apartment would like to join us for security. UPS packages stolen from front porch. Film footage shows two females, that followed the UPS Truck. No license plates visible.

E) **Superneighborhood-** Rene Garza – At the recent Superneighborhood meeting, Mark Kirschke says there is an application that needs to be filed with the City. We will pay half and Greg Travis's office will pay half for the Speed Cushions. Rene has the application and the Board will sign tonight. We need 16 signatures. We will go through the City and pay half the money. Rene Garza made a motion and Jennifer Jackson seconded. The motion was approved. Other discussion at the meeting was to abandon the shopping cart program. Gessner will be widened to six lanes in 2019 from Richmond to Briar Forest. Panhandling Program, moving people from under underpasses. Meaningful Change Program is a program to get beggars off the streets. This ordinance is weak due to constitutionality questions. Camping on Public Propert (Underpasses) will be illegal starting 5/12/17. The Buckingham has filed an affidavit of trespass and the police have started to move people off the Bayou. Hurricaine Workshop at the GRB on June 3, 2017. New Laws- HB 1368- if no posted speed limit, the limit is 25. Stop the sale of sealed alcoholic drinks at drive up windows on Richmond. New Law to ticket cars parked in yards. There will be an Election on November 7, 2017. Several Bond issues will be on the Ballot Next meeting is August 14, 2017.

F) ACC- Jennifer Jackson-Nothing to report.
