- I. Call to Order Larry Stanton called the meeting to order at 7:20 pm.

- II. Introduction of Visitors
  - A) No visitors attended the February meeting.
- III. Reading Minutes of Preceding Meeting-
  - The January minutes were presented. A correction was made to the January minutes regarding the board members who are up for re-election. Casey Koehler has one more year to serve. A motion was made to approve the amended minutes by Charlie and seconded by Peter. Minutes approved.
- IV. President's Comments- Larry talked about the new speed bumps and is afraid they might not last long.
